Background and description of knowledge gap to be addressed:

The persistence of cannabis legalization across the U.S. has caused an increase in cannabis use both medicinally and recreationally. Unfortunately, there has also been an increase in cannabis use disorder diagnoses. Substance use disorder service providers are being tasked with assessing, diagnosing and making treatment referrals and recommendations for clients with cannabis use disorder. It is imperative that staff at these agencies are knowledgeable in this subject matter to ensure the client has the greatest chance to achieve recovery status.

The goal is to provide comprehensive cannabis use disorder education to clinicians at the DC Department of Behavioral Health Assessment and Referral Center. This education equips the clinician with knowledge to effectively engage persons who may have cannabis use disorder.

Possible points of discussion include, but are not limited to:

- identifying risk factors
- assessment/screening tools
- utilizing diagnostic criteria from the DSM-5
- treatment options
- differentiating cannabis use disorder from cannabis intoxication and other cannabis disorders

Because opioid use disorder is a prevalent diagnosis seen in the Assessment and Referral Center, incorporating cannabis and opioid drug interactions as well as the science behind concomitant use and increased risk for overdose are also topics to be considered.

Cannabis is a medicine and just like any other agent, there is proper use of the medication but the potential for abuse also exists. It is important as a clinician to not allow stigma to cloud one's judgment when differentiating a client who uses cannabis versus one who qualifies for a clinical diagnosis of cannabis use disorder. Effectively diagnosing and treating cannabis use disorder can enable clients to achieve their personal treatment goals, whether it be to adhere to a healthy cannabis utilization regimen or abstinence.
